Flexible approach

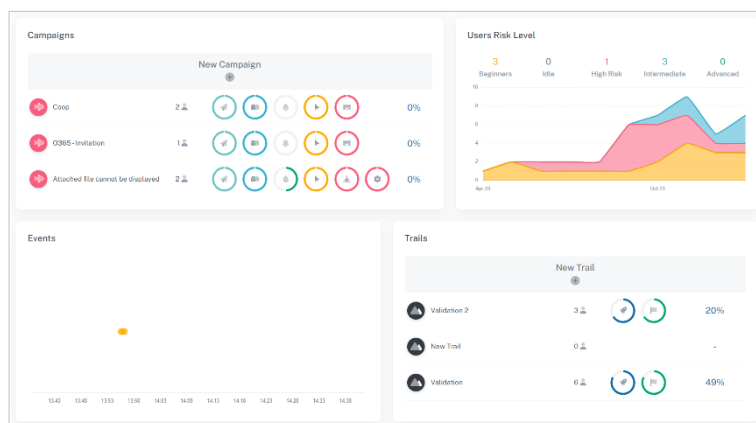
No need to upset everyone's working schedule to organise awareness sessions: the challenges take a few minutes at a time and users can complete them from their workstations or mobile devices.

Gamification

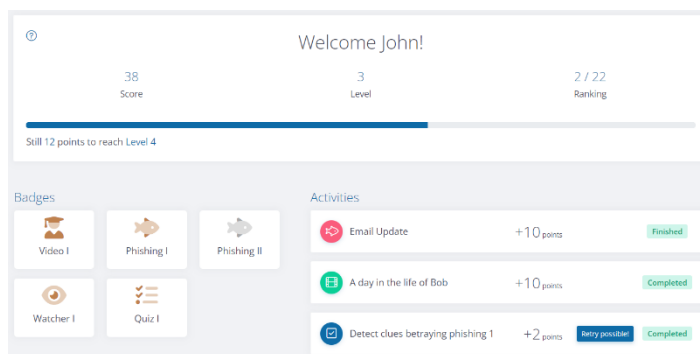
Users earn points for each challenge they complete. The more active they are, the more they improve their score. For added motivation, they can track their progression on their personal dashboard.
